

EisnerAmper Wealth Management (“we”, “us” or “our”) is registered with the U.S. Securities Exchange Commission (“SEC”) as an investment adviser. Investment advisory services and compensation structures differ from that of a registered broker-dealer, and it is important that you understand the differences.

What investment services and advice can you provide me?

We provide investment advisory services, including discretionary investment management and advocacy management planning services to individuals, trusts and estates (our “retail investors”).

When a retail investor engages us to provide discretionary investment management services we shall monitor, on a continuous basis, the investments in the accounts over which we have authority as part of our investment management service. Furthermore, we shall have the authority, without prior consultation with you (unless you impose restrictions on our discretionary authority), to buy, sell, trade and allocate the investments within your account(s) consistent with your investment objectives. Our authority over your account(s) shall continue until our engagement is terminated.

We offer investment management and advocacy management planning services as part of our standard investment advisory service engagements. However, we also may be engaged to provide investment management, advocacy management planning or financial planning services on a separate fee basis. When we provide advocacy management or financial planning we rely upon the information provided by the client for our financial analysis and do not verify any such information while providing this service.

We do not limit the scope of our investment advisor services to proprietary products or a limited group or type of investment.

- *What is your relevant experience, including your licenses, education and other qualifications? What do these qualifications mean?*

What Fees will I pay?

When engaged to provide investment management and advocacy management planning services, we shall charge a fee calculated as a percentage of your assets under our management (our “AUM Fee”). Our annual AUM Fee is negotiable but generally does not exceed 1.50%. However, we impose minimum fees as follows: Investment Management Only - \$2,000; Advocacy Management Planning only - \$4,500; Combined Discretionary Investment Management & Advocacy Management Planning - \$6,500. Also, those clients who choose to engage our services through the EisnerAmper Automated Portfolio Strategy, must have \$5,000 in their account.

We typically deduct our AUM Fee from one or more of your accounts, in arrears, on a quarterly basis. Because our AUM Fee is calculated as a percentage of your assets under management, the more assets you have in your advisory account, the more you will pay us for our investment management services. Therefore, we have an incentive to encourage you to increase the assets maintained in accounts we manage.

We also offer our advocacy management planning and financial planning services on a stand-alone basis for either a fixed fee or on an hourly rate basis.

Other Fees and Costs: Your investment assets will be held with a qualified custodian. Custodians generally charge brokerage commissions and/or transaction fees for effecting certain securities transactions. In addition, relative to all mutual fund and exchange traded fund purchases, certain charges will be imposed at the fund level

You will pay certain fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

- *Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?*

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. As an example, a number of our financial professionals are also registered representatives of APW Capital, Inc. (“APW”), an SEC registered broker-dealer. Therefore, your financial professional may offer you brokerage services through APW or investment advisory services through us. Brokerage services and investment advisory services are different, and the fees we, and APW, charge for those services are different. It is important that you understand the differences. Your financial professional may earn transaction-based compensation and have additional conflicts of interest as a result of providing brokerage services through APW. Our financial professionals generally only recommend investment advisory services to our clients and generally use APW Capital, Inc. for, smaller accounts, in-kind transfers from new clients, and/or legacy business.

How do your financial professionals make money?

Our financial professionals are generally compensated on a salary basis.
